1.1 Refer to Drawing Sheet A2.1 DEMOLITION PLAN.

Add Alternate #1 demolition scope as follows: Sawcut concrete and asphalt and excavate as needed for the install of the two new Trench Drains in Apparatus Room 115 and the new Sand-Oil Interceptor in the Paved Drive.

1.2 Refer to Drawing Sheet A2.2 FLOOR PLAN.

Add Alternate #1 scope as follows: Install trench drains with minimum 6" concrete on sides and bottom of trench. Install concrete or asphalt patch around sand oil separator. Seal entire concrete floor in Apparatus Room 115 with clear, water-based, water-repellent, penetrating concrete sealer.

Revise Lower Casework in Laundry Room 111 as follows: Counter to extend all the way to the east wall, as shown on Sheet A4.1, CASEWORK ELEVATION/LAUNDRY ROOM 111/ELEV 'A'.
