11. FIRE CHIEF'S REPORT

Chief Hardy reported on a significant fire on Main Street. Chief Hardy reported that the District lost our Fire Prevention Officer who took a position at Contra Costa Fire. Chief Hardy stated with the Union's input it has been decided to fill that position with a firefighter/paramedic. Chief Hardy stated as part of the reorganization, the District is going to institute a second floater. The spot is going to come from the firefighter spot at Station 72. To maintain the level of service, three Captain/Paramedics have volunteered to work at 72 temporarily. Chief Hardy stated the District is hiring three new apprentices to fill the vacant spot at Station 72. Chief Hardy reported the District was awarded a tribal gaming grant. With that grant funding the District is accepting bids for an ATV with a fire mounted pump attached and hose real with a shed to park it in. Chief Hardy reported on his attendance to the League of Fire Boards. The next meeting for that board is March 27 at 5:30 at Fifty Grand in Pollock Pines. Chief Hardy reported that the District did not get approved for the 2012 AFG Grant.
