- 1. Q.) Will you require locks and number plates on the Salsbury lockers? I have them included in my bid.
 - A.) Number plates: yes. Locks: no. The specified locker type has a lift-up handle & recessed hasp that enables each person to use their own lock.
- 2. Q.) Are all walls on the existing living quarters wood frame? Just want to make sure there are no block walls.
 - A.) Please look at the indicated wall types included on Plan Sheet A2.2. Some walls are wood frame and some are CMU block, as indicated on that plan sheet.
- 3. Q.) Who will be responsible to clear snow off the premises?
 - A.) The Owner will be responsible for snow clearing on the project.

 - USG Ceilings 2'x4' Radar Basic White Square Edge Lay-In Ceiling Tile (Model #R2310), or approved equal.
- 7. Q.) Regarding KEYNOTE 016 on Plan Sheet A2.2: This keynote indicates new walls, not existing ones, correct?
 - A.) Yes. That is correct. The indicated walls should be shaded gray on the plans to indicate that they require new wood stud wall framing.
